

## Sovereign by Design

4. So before we begin, as always, we need to do a disclaimer that this is not legal advice, and its up to everyone to do their own due diligence to find solutions that feel right for their level of knowledge, confidence and competence. This is a private discussion with all rights reserved no third party interference or surveillance is allowed.
5. Today is February 25 2021 so that anyone listening to this has context on when this webinar took place as information and processes change over time. What may be true today may not be tomorrow as we learn, integrate and implement more of our knowledge and abilities.
6. Today we will do an overview of the many ways you can approach what is going on that violate your rights and inherent jurisdiction as a non-franchised Canadian national/foreign national. Aka sovereign. We are not talking about sovereign citizen because there is no such thing and its an oxymoron...they cannot exist in the same sentence. You are either a citizen or a sovereign and the law makes a huge distinction between the two.
7. So if you have questions as I am speaking or something I've said is complicated, then please enter your question in the chat area and I will have that open as I speak so I can answer in time with what I'm saying.
8. Take note, I have chosen my words carefully and specifically for a broad spectrum of applications to help you develop not just the logical responses to situations, but to be able to identify the internal mechanisms and quandaries that affect your choices.
9. Keep always in your mind and heart that God granted you dominion over the earth, that makes you his son/daughter/heir. And he gave you possession of it as long as you follow the laws – we have both spiritual/temporal vs legal/statutory corporate codes. What does that mean? You have perfected title in God's world to use. That in law is usufructory...or usury
10. God owns earth and its dominium, *n.* [*L.* from *dominus*, lord.] **In law, ownership; authority; complete title.**

11. The government will claim that they have complete control over the dominion you may express as Canada and under military necessity they will presume to be able to do so. However they are all still just corporate fictions.
12. Now this is not to say that I do not see the need for police or military control when its vested interest is to protect the people from foreign or domestic threats and not special interest groups or to protect political office holders from being prosecuted, which is what we are seeing today.
13. We will also be covering both the legal/law and spiritual solutions you can do using creative approaches. Some will be out of the box and ultimately it's up to you to decide.
14. Are you ready, willing and able to take the helm? Do you have the mental, emotional and spiritual capacity to do so? In my mind, this is a journey that requires balanced perspectives with good intentions and tempered ideals balanced with society needs so as not to bring the system too out of balance like it is now.
15. If you're ready to ditch the man created state god, then what? What is your plan? What is your vision? How will you perform, behave and operate within or outside of the fiction world. Think before you leap. And if you leap, at least have contingencies if things go south. And always have someone that can bail you out of jail, or learn how to bail yourself out or have some sort of back up control as a power of attorney/proxy.
16. Over the past week I have had a few discussions with a retired military general that wanted to reiterate that lots is going on in the background particularly the Nuremburg trials that are in process against government deep state. Clean up continues at the Vatican, City of London (the restricted section, not the UK part), and DC.
17. My contact said that the enemy is at our door and some of us will need to make some hard choices as we go forward. The deep state as they are called, or delinquent government agents, are attempting to re-constitute the slavery program that many of us have been waking up over the last many years, particularly the last 10 I would say.
18. Today we heard that there are more than 60% of the population that is awake to what is going on and what's been done to them, so the other side is scared. Hence why they need to create these fear programs to attempt to stay in control.
19. And this is good news, as I've said before, the beast will eat itself out from the inside as it feels it is invincible. This is the time you came here for. You have a unique skill set to be able to set things back to the 1000 years of peace, otherwise you wouldn't have been born at this time.
20. So you need to remember that going forward and hold this in your heart when things start to get tough or you're standing on your last line of defense. You have a valuable contribution to what is going on, you just have to discover that inside of you.
21. The only way that they can retain control is to instill fear in us, hence why we are being suppressed, subdued and threatened. Where there is a growing darkness, so too must the light grow so that we can see our way forward. So be mindful and diligent each day to check the level of fear you have inside of you and consciously return to sender....

22. In case you haven't noticed, we are already in war. Governments around the world are shut down and nowhere to be found other than the TV screen of the fake media propaganda machine, segments of the police force are involved in what appears to be renegade code of misconduct against our manitarian rights both domestically and internationally. I use the word manitarian because human is an animal.
23. You can find this definition clearly in US Code title 7, Chapter 6 Subchapter 11 s 136 – the term animal means all vertebrate and invertebrate species, including but not limited to man and other animals.
24. We see a lot of business owners following suit on rights violations, notably Canadian Tire, Costco, Interior Health, WCB (workers compensation), police and government departments, all conspiring, and many unknowingly thinking that they have a moral duty to protect society from some sort of virus.. little do these businesses know that they become a party to these crimes as they are the consitututors/the executioners of these programs which, under international law – no one can suspend your rights under any circumstances during an emergency...See nuremburg Instead of a jewish star, we are wearing a mask.
25. If there were truly a virus, then yes I would say measures need to be in place, but we see how they define cases, we know that multiple governments have banned the PCR test as it has been proven that it was not created to detect a covid case. And some might say this becomes a moral issue. The moral issue of protecting society versus the individual?
26. So what moral dilemma are we speaking of... To wear a mask or not. My answers to this include, but not limited to: do you have an immune system? Do you know what my medical history is? By what authority do you have to tell me to suffocate myself? If you believe your vulnerable then why aren't you wearing a full hazmat suit. I've been walking around for over a year without a mask and have picked up nothing except the usual seasonal allergies. So it's up to each individual to protect themselves.
27. Each and every one only has the right to protect themselves technically. Anything outside of that may be deemed interference and in the spiritual world, you may end up wearing the consequences of your interference. So those for instance, that are violating Nuremburg codes, human rights codes, consitutions etc.. will all wear the conviction and indictment consequences.
28. And without going into a lengthy intellectual debate about choices here, that statement in itself is enough to stand on your circle of influence.
29. So here's the other thing.... If it's an airborne illness, then are they going to wrap the planet in a mask? Stop the air from circulating? Why aren't they insisting on restaurants changing their air filters or cleaning their air ducts? Have you seen the filth in some of these air vents? Surely there's more disease in those particles over time. So see the illogic that is taking place?
30. When you can see someone's reactivity to the situation, it likely is a sign they feel they are being threatened or feel in danger in some way. In the US I've heard people are getting shot for not wearing a mask. And many of us, like me, can't.

31. If someone is at a lower consciousness level, meaning lower innerstanding of the law and their rights or lower vibrational frequency, their reactivity to the situation will be excessive and more illogical.
32. What's the more dangerous road to take? Ignorance, willful blindness, a term the CRA uses frequently or competency, logic and self-awareness? Do you see why we are still classified as infants/incompetents in court?
33. Wouldn't you say that people are being challenged in their ability to know their rights, know the law and their competency levels? So consider mamma and papa bear governments taking your training wheels off so you can learn to ride your bike on your own. Halleluliah.
34. The government may not have announced martial law, but I believe we are in a world-wide shut down, no holds barred, lets' see how the people will respond, tactical persuasion.
35. And when this happens, the Military is the dejure government to maintain the peace.
36. Please take notice that we are not advocating violence, however, if your family and your castle is being attacked, you have every right to self-defense. And it is right now for the past year, but even longer, since the beginning of the papal rule.
37. And since this has been pre-meditated with the fact that Canada in the last 2 years has passed more restrictive gun control acts, removed the defence of property from the criminal code October 31 2020 and other such destructive devices of warfare.
38. So what does it mean when the military is in control? They will exercise whatever means necessary to protect the country (as is it commonly referred to as Canada), although we know its just a corporation, from any enemies, domestic or otherwise.
39. So you may just be deemed a belligerent and enemy combatant. And if there was a Canadian constitution to begin with, as we know there isn't, it gets suspended during times of emergencies.
40. From the article called Human rights emergencies and the rule of Law...“military order” issued by President George W. Bush on 13 November 2001, authorizing *inter alia* “indefinite detention” of noncitizens suspected of terrorism and trial by military commissions.<sup>16</sup> Agamben observes that President Bush's order “radically erases any legal status of the individual. . Neither prisoners nor persons accused, but simply ‘detainees,’ they are the object of a pure de facto rule, of a detention that is indefinite not only in the temporal sense but in its very nature as well, since it is entirely removed from the law and from judicial oversight.”<sup>17</sup> The Schmittian implication is that the US president, like Schmitt's sovereign, has absolute and unfettered power to identify and confront perceived threats to national security.”...
41. ...Such emergency measures preserve, rather than subvert, a legal order in which no person is subject to another's unilateral discretionary power..... Once legal restraints are relaxed or abandoned, emergency powers can become permanently entrenched, facilitating the further abuse of public powers long after the crisis has passed. Recognizing the dangers that accompany states of emergency, international law limits the circumstances under which states may legally derogate from their international obligations to respect, protect, and fulfill civil and political rights.<sup>28</sup> Each of the leading international and regional conventions on civil and political rights—the ICCPR,<sup>29</sup> African Charter on Human Rights,<sup>30</sup> American Convention on Human Rights (ACHR),<sup>31</sup> Arab Charter on

Human Rights (Arab Charter),<sup>32</sup> and European Convention on Human Rights (ECHR)<sup>33</sup>—employs a two-stage inquiry to evaluate the legality of a state’s derogation from general human rights standards.

42. “Specifically, we argue that human rights emanate from a **fiduciary relationship between public institutions and persons subject to public powers**. As fiduciaries, public institutions bear legal obligations to safeguard their subjects against domination—subjection to the threat of arbitrary state or private interference. Public institutions must also satisfy the Kantian principle of non-instrumentalization by ensuring that all persons are regarded always as ends-in-themselves and never as mere means. On this fiduciary theory of the state, human rights come into focus as institutionally **grounded legal constraints** that arise from a state’s assumption of sovereign powers. Because a state’s fiduciary obligations are constitutive of its legal authority, **public institutions cannot violate these obligations during emergencies without undercutting their claim to represent their people as a sovereign actor.**”
43. We are seeing many inconsistencies in the way the government is handling the covid pandemic crisis, if we can even call it that anymore. We seen records from as far back as 1999 about the COVID virus patent, Fauci’s articles on COVID, long before the term became famous.
44. Enforcers are even confused about what to enforce in terms of the mask rule. Wear a mask or don’t wear a mask. Just remember, all humanitarian rights co-conspirators during the Nazi era were also convicted.
45. In light also of the Adamson barbecue article where the city sent a \$187K bill for police services, people need to be reminded, that they too can issue the city an invoice. It works both ways. Your business was shut down by an order... so when you order food or a service, don’t you have to pay for it? Order generated, invoice due.
46. We have every power at our disposal to stop what is going on. Notices, Conditional acceptances, declarations, Vetos, Indictments and Orders.
47. When you petition or motion the court, you are asking permission from a corporation so you can, as the sovereign, or as the principal of your own estate/affairs, direct and order the court to obey you and require a court of inherent jurisdiction not admiralty where you have no rights. When you ask permission it can and is usually revoked by the judge or the lawyer motions the court to quash your evidence or appeal. There is no equity in that case. So you must insist on a court with inherent jurisdiction should you find yourself in that situation.
48. I will be speaking with a few people who have been successful in this arena next week.
49. Also remember, all they need you to do is provide some form of consent whether it be you granting them access, jurisdiction or your name.
50. You can quash court cases by filing in your paperwork ahead of time. Depending on how you position yourself on paper. You are always a man or a woman but they can only see fictions in their court jurisdiction. But in their jurisdiction, you are most certainly principal and heir.
51. Remember also, that government are servants to us and cannot claim immunity as they are fiduciary trustees with a fiduciary responsibility. Thus they have more liability than the average man or woman because they accepted that liability when they came into office. Hence why they carry

liability insurance. When they attempt to claim immunity from prosecution they cannot. All are equal at law and they accepted to be the public trustee as a condition of acceptance of their office.

52. So what is a notice? A notice in general is a business letter either challenging something, citing or claiming something in writing. You have a right to demand evidence of debt, evidence of liability and authority. When you are making a declaration of something, like a change in your status, that becomes a decree or declaration – it's a public notice of a change in your standing or rebutting presumptions.
53. A general notice can be done 3 times before the other party goes into default. Then you need to decide how far you want to take this. At a 3<sup>rd</sup> notice – usually a default, you are in a lien position. So you must decide also, what the value of the default is. What losses did you sustain, what injury or harm occurred and who did it to you. You can file this lien into the PPSA, or with the court, but since we are not sure if the PPSA is still valid, you may consider a notice of lien and send to the oversight parties like transunion, Equifax and other banking institutions. They may likely require a court order for this however, the CRA never gets one before they issue their Requirements to Pay.
54. I did find a document that stated the birth certificate is a deed. What is a deed? It's a title document.... And since God our creator gave us dominion and possession this deed document evidences your interest and lien on the public for your contributions.
55. A declaration is a legal document that embodies what you wish to announce. Such as that you are living, of the age of majority, that your name is not a corporation – this is called a corporate denial. You can declare your association or non-association to a government entity, society or group. You can also declare the dissolution of something like a dissolution of partnership or marriage as each of these are just a corporate merger.
56. And you may wish to do a declaration rebutting some presumptions of facts like they always use in court to charge you with victimless crimes or declare a change in your status.
57. When you sign the passport application you make a declaration about your citizenship and when you come through the border each time, you also make a customs declaration... this in a way is a statement of fact that you are attesting to.
58. Whenever you fill out an application for services, you are always making a declaration. How you reserve your rights is key...always always, qualify your signature or autograph. A signature usually accompanies an office being held, like principal, executor, agent, guarantor, and writing all rights reserved, without recourse on applications is the way to preserve conditions without having to modify the entire contract, all though when I bought an automobile, I scratched out all the legalese on the back of the document. They weren't too happy but I had every right to do so.
59. An autograph usually denotes you coming from the private non-statutory side. Things like private beneficiary, heir, woman/man.
60. Most applications are forms of deeds/title documents that get conveyed and you can also reserve and protect your rights by writing at the top of these documents Private, Special Deposit in Trust....express the trust....
61. When dealing with governments and other service agencies you should and is prudent to do so...to express the relationship in the form of a trust....express trust or constructed trust. We know that

banks and government are trustees...they hold valuable assets in their possession on our behalf and thus makes them trustees. They are also in charge of the public well-being to oversee it's care and management, and thus also a trustee.

62. Court officers are trustees and administrators....and are thus trustees...
63. So in the case of COVID, the government has interfered with your right to necessities under criminal code section 215 – duties of persons to provide necessities of life.
64. **UNITED STATES v. PEWEE COAL CO., Inc. 341 U.S. 114** (71 S.Ct. 670, 95 L.Ed. 809), No. 168. Argued: Jan. 2, 3, 1951. Decided: April 30, 1951.
  - a. *“Whatever might have been Pewee’s losses had it been left free to exercise its own business judgment, the crucial fact is that the Government chose to intervene by taking possession and operating control. By doing so, it became the proprietor and, in the **absence of contrary arrangements**, was entitled to the benefits and subject to the liabilities which that status involves.”*
65. Note it says, in absence of contrary arrangements...meaning you haven't made them with the government...however, if this being the case, they are the owners and we are the holders, then what are they charging us for? And as we are the holders then, acting like trustees for the owners and the crown, we should get those payments we made back on behalf of the owner shouldn't we? These are the things they don't want you to know. Even though it says in their public documents you are entitled to do so.
66. Senate Doc #43, page 9, second paragraph in the right column.
67. *“The ultimate ownership of all property is in the State; individual so-called “ownership” is only by virtue of Government, i.e., law, amounting to mere user; and use must be in accordance with law and subordinate to the necessities of the State.”*
68. And in Canada, this is refer to escheating to the Crown....all property vests in the crown until you come forward from the dead or if you die intestate or fail to claim your inheritance, all property returns to the care and management of the Crown.
69. Who is the state? What state are you? Isn't your name your own sovereign territory? Called the state of Smith? Or the state of man? Or state of the dominion heir
70. So what does escheat mean? [escheated](#) property
  - b. the reversion of lands in English feudal law to the lord of the fee when there are no heirs capable of inheriting under the original grant
  - c. the reversion of property to the crown in England or to the state in the U.S. when there are no legal heirs
71. So what is happening today under the emergency orders? Canada has not technically called for martial law, but emergency situations call for martial rule. What can occur under martial rule? The suspension of your rights, the seizure of property and forfeiture of whatever else is necessary under military control. What do we see happening in Washington? What do we see in Canada?
72. Here is what Article 38 of the Lieber Code says: **Art. 38.**

73. "Private property, unless forfeited by crimes or by offenses of the owner, can be seized only by way of military necessity, for the support or other benefit of the army or of the United States. If the owner has not fled, the commanding officer will cause receipts to be given, which may serve the spoliated owner to obtain indemnity." Spoliated means that you have been they have plundered, robbed, ruined you.... So ask for a receipt for your losses...aren't you incurring losses right now?
74. When they issue you a receipt, that provides you an indemnity for any charges and claims...that would be an interesting process to develop....since the US and Canada have been in a banking emergency since 1933, we should've been asking for this then any charges against you would be barred.
75. Robin v. Hardaway 1772....
76. *"Now all acts of legislature apparently contrary to natural right and justice, are, in our laws, and must be in the nature of things, considered as void. The laws of nature are the laws of God; whose authority can be superseded by no power on earth. A legislature must not obstruct our obedience to him from whose punishments they cannot protect us. All human constitutions which contradict his laws, we are in conscience bound to disobey. Such have been the adjudications of our courts of justice. And cited 8 Co. 118. a. Bonham's case. Hob. 87; 7 Co. 14. a. Calvin's case."*
77. So this is why I have said, in other sessions, what side of the ledger are you standing on....
78. In fact, Canadian case of Patrick Palubjak, which we have posted on the telegram group states, decided February 6 2012, that there is 'no provision in the Canadian legal system which allows an individual to transfer his given names to anyone, whether a person, corporation or trust. and any document purporting to contain such is void"
