Document Summary: The STAMP

1. The Stamp as a Flag: Jurisdictional Declaration

"A flag is a declaration of the law under which you stand."



5. The Living Claimant as Postmaster

"He who controls the seal controls the contract."

The use of the stamp establishes your role as:

Appendix A: Legal Footnotes and Sources for Stamp-as-Flag Doctrine

1. Revenue Act of 1862 – U.S. statute requiring adhesive revenue stamps on legal instruments, establishing duty-paid authenticity; also mirrored by U.K. Stamp Acts of the 17th–19th centuries.
2. U.S. v. Isham, 84 U.S. 496 (1872) – Recognized the legal necessity and evidentiary validity of stamps on documents for court admissibility.
3. Restatement (Second) of Contracts §96 – Explains the enforceability of instruments under seal, an element fulfilled by autograph and stamp.
4. Uniform Commercial Code (UCC) §3-401 – Defines signature as a means of authenticating a writing, which includes hand-written names or symbols.
5. Universal Postal Union (UPU) Treaties – Treaty obligations governing international postal systems as lawful venues; Berne 1874, Vienna 1964. The use of postage implies international trust participation.
6. Common Law Equity Maxim – “Equity regards as done what ought to be done,” used in private trust doctrine to give effect to intent and performance through bonded instruments.
7. Historical Notarial Practice – Notaries and postmasters historically affixed stamps and seals to authenticate contracts, demonstrating a long-standing legal tradition of paper-to-instrument transformation.
8. The Law of Trusts by George G. Bogert – Notes that seals, stamps, and handwritten endorsements are essential to establishing fiduciary intent and standing.

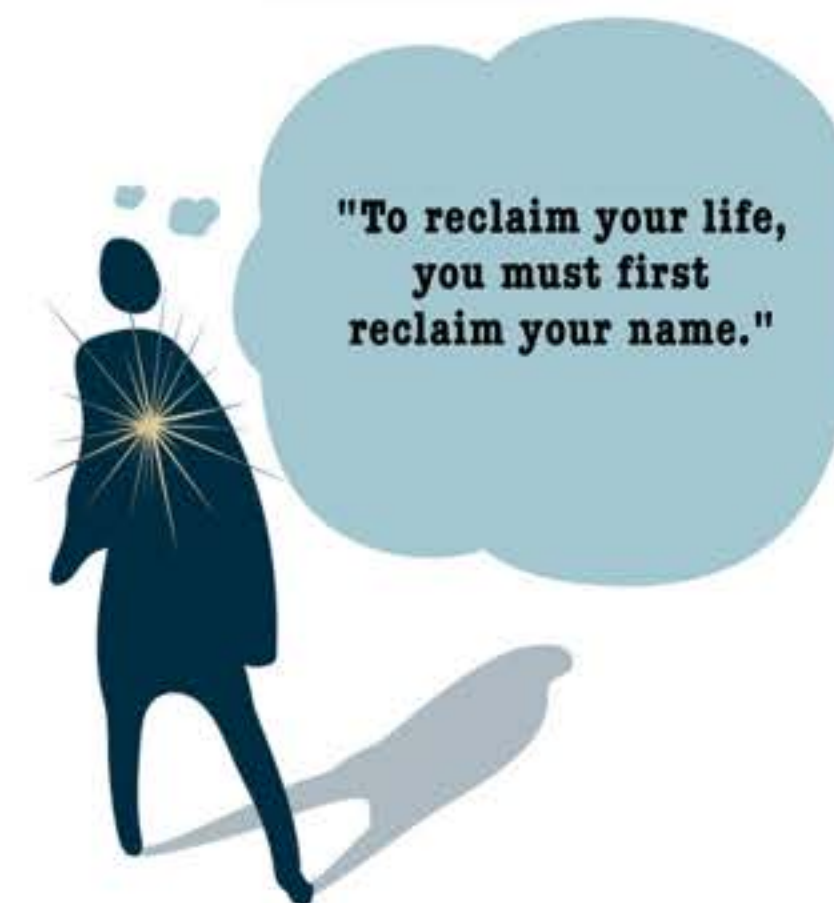

Every time a government, agency, or institution issues a new variation of your name—such as on a driver's license, passport, social security document, or court filing—it often functions as the creation of a new derivative instrument, trust, or commercial account tied to that specific iteration.
